

The BCA Credit Card is a card payment method issued by BCA for transactions and cash withdrawals. BCA settles the payment obligation in advance, and the cardholder must pay at the designated time, either in full or in installments.

A Key Features

- Can make transactions at merchants (online and offline) and BCA ATMs with the Visa/Mastercard/UnionPay/JCB logo (according to the logo on the card).
- Can make contactless payments (for cards that already support contactless payments).
- BCA Installment is available
- Cash withdrawal and shopping transactions accrue interest at 1.75% per month
